Keynote speaker Chris Anderson, editor-in-chief of *Wired* and best-selling author of *The Long Tail: Why the Future of Business is Selling Less of More*, disclosed ways to connect people with products in non-traditional ways. Keith Powers, executive vice president for strategic development at the X Prize Foundation, shared the inside story of how the foundation created a private race to space with its \$10 million Ansari X Prize. Presentations and panel discussions also featured executives and experts from Corning, Chevron Technology Ventures, Google, IBM, and Microsoft, as well as other companies and venture capital firms.

## **REGIONS**

### **San Diego**

Florida is matching California's \$1 billion investment in biotech. California is by far the more populous state. The (predictable) result? Scientists are moving from California to Florida. (See the spring, 2006 issue of this newsletter.) And from California to Singapore and elsewhere in Asia. San Diego, a pioneer in biotech, is still adding jobs at the low end but losing them at the high end. Venture capital has gone scarce for the kinds of biotech start-ups in which San Diego has always been strong. There's hope for San Diego – see Julie Meier Wright's 12/10/06 article in the San Diego *Union-Tribune* – but the town remains dominated by real estate developers (see Singaporean Philip Yeo's quote below about the relative importance of educated people vs. buildings), and if the *Union-Trib* is to be believed (it's a politically conservative, generally anti-government paper), San Diego is governed by the most clownish city council I've seen in decades of studying technopoleis around the globe. IC<sup>2</sup> Institute Senior Fellow Mary Walshok is also here (she's a professor of sociology at UCSD, researching the technology-based economy). Her recent article for the *Union-Trib* supports everything I've told you in my new book *The Technopolis Columns*.

### **Singapore investing heavily in biotechnology**

Singapore is luring top scientists from the US and Europe, according to the San Diego *Union-Tribune* (12/18/06). Last year, the city-state put \$45 million into a new research consortium for stem-cell research. The organization will be led by a California scientist who left the US after President Bush restricted US funding for stem cell work. Singapore will push USD 25-29 million into the stem cell arena every year, emphasizing education and research. Philip Yeo, chair of the Singapore Economic Development Board and mastermind of Biopolis, says, "People are the future, not buildings."

### **Ireland's focus on high tech, low tax attracts the young and ambitious**

Ireland has been transformed into the land of opportunity and a magnet for knowledge workers from Eastern Europe and around the world. Ireland's "brain gain" is driven by the European operations of Google Inc., Yahoo, eBay and others. "The place is very young and very international," said one Norwegian in-migrant.

Ireland's 12.5 percent corporate tax rate is the lowest in Europe, its per capita GNP is the European Union's highest, and its unemployment is the EU's lowest. English is spoken, American culture is appreciated, and it's an easy gateway to Europe.

Of Google Ireland's 800 employees, 70% are not from Ireland. They speak 37 languages. "The company plans to hire another 600 university-educated, mostly foreign people," according to AP.

A third of the more than 1,000 multinationals located there conduct research and development in Ireland. Ireland offers a 20% tax credit for R&D. "Ireland ranks at the top of the EU's 15 original members in having enterprises with innovation activity, according

to a 2004 Eurostat report.”

### **TOP OF THE NEWS**

**Bangalore, India, Changes Its Name.** (November 2, 2006 The Egyptian Gazette)

"India's technology hub of Bangalore changed its name to its vernacular origin Bengalooru yesterday in what is seen as a bid to appease locals upset at the influx of outsiders. The name change was announced to mark the 50th anniversary of Karnataka state, of which the city is the capital. However, the change is expected to take about a month to come into effect legally as it needs federal government approval, a senior state official said."

### **Case Could Change Patent Law (AP, 11/29/06)**

We may finally see the “non-obvious” criterion for the granting of a patent enforced more strictly. Hearing oral arguments in *KSR International vs. Teleflex Inc.*, the US Supreme Court “signaled a willingness to make patents harder to obtain.” The court focused “on whether an invention is obvious and therefore ineligible for a patent.”

### **Alliance for Regional Stewardship Awarded \$1 Million Challenge Grant**

Philadelphia, PA, December 5, 2006: The Alliance for Regional Stewardship (ARS) announced it has been awarded a \$1 million challenge grant to further its growth and development as the nation's only public-private organization dedicated to building strong regions. The grant was made by Becky and Jim Morgan of Los Altos Hills, CA. Jim Morgan is Chairman of Applied Materials, Inc., headquartered in Santa Clara, CA. The Morgan family funds will be used to grow the ARS Learning Network, which supports civic activists in their regional work by identifying and teaching best practices.

Two contradictory items in December’s *EE Times*. A technology executive says, “With Sarbanes-Oxley, who in their right mind would want to sit on a corporate board?” Yet *EE Times*’ top stories of the year involved ethical lapses on the part of technology execs.

If executives are unethical and regulation doesn’t fix it, then more radical measures

are called for. I don't know what they are. I invite your input, and will publish selections from your remarks in the next issue of *Review of Technology & Economic Development*.

I continue to enjoy reading *European Innovation* (<http://ali.cordis.europa.eu/>), despite that this government organ clings to the notion that in our networked world, matters of innovation can still be directed centrally. The November 2006 issue, though, said something eminently sensible: "Building on its review of the copyright acquis, the [European Commission Directorate-General for Enterprise and Industry will] ensure that the legal framework and its application are conducive to the development of new digital products, services, and business models." This is the right approach on two levels. "Making the legal framework conducive" is indeed one of the best functions of a central government. Secondly, the Commission recognizes the importance of creative new business models.

This is a sophisticated understanding that is often lacking elsewhere. Kudos to the Commission.
